Council Member Frank Brinkley made a motion to appoint these individuals for these terms. The motion was seconded by Council Member Wannetta Carlton and approved unanimously.

Nuisance Vehicle Ordinance Discussion

Manager Bergman stated that a draft of the Nuisance Vehicle Ordinance had been presented at the last meeting and Council indicated that they needed more time to review it. While discussing individual sections of the draft ordinance it was determined some omissions needed to be corrected, and addition of the steps taken post towing should be included. Council Member Jeff Carter asked to see photos of nuisance vehicles in Wallace to illustrate the definitions. The photos will be sent to the Council.

Police Department Overview

Police Chief Jimmy Crayton made a detailed presentation to the Council regarding the Police Department. Chief Crayton talked about community events, on-going projects, upcoming training and the Wellness Plan. He discussed staffing issues, employee turnover, recruiting and salaries. Responding to a question from Council Member Wells, Chief Crayton said he would like the Town Manager and Finance Director to see if funds could be made available for salary increases in the current budget.

Amendment to 2021 Regular Meeting Schedule

Town Clerk Jackie Nicholson asked the Council to approve and amended meeting schedule for 2021 to include a statement that all meeting will be available to the public via electronic means and one or more Council member may participate remotely. The meeting dates and time remains the same.
