The Wallace Town Council held its regularly scheduled monthly meeting in the Council Chambers at the Town Hall.

Mayor Jason Wells called the regular meeting to order with a quorum of the governing body members present and the invocation was offered by Council Member Jason Davis.

The Pledge of Allegiance was recited.

<u>Presentations</u>

Airport Manager Gage King provided an update on land acquisition and road design for the expansion project and talked about the AWOS (Automated Weather Observation System), future projects such as the runway rehabilitation, east taxiway and the terminal building. He said that sales and traffic are down right now.

Adoption of the Agenda

Mayor Wells called for discussion of the agenda. Items were added for a presentation by Wallace ABC Board and an administrative item from previous street closings. Council Member Jeff Carter made a motion to adopt the agenda as amended which was seconded by Council Member Francisco Rivas-Diaz and approved by unanimous vote.

Public Comment Period

None.

Consent Agenda

Mayor Wells called for discussion of the minutes from the October 13, 2022 meeting and the November 3, 2022 Special Called meeting. There being no additions or corrections Council Member Wannetta Carlton made a motion to approve the minutes as submitted. The motion was seconded by Council Member Rivas-Diaz and unanimously approved.

Finance Director Rob Taylor presented the tax report and four (4) tax releases with no refunds totaling \$967.95.

Council Member Davis made a motion to approve the proposed tax releases which was seconded by Council Member Carlton and approved unanimously.

Budget Amendment FY23-1 was presented for purchasing the existing Welcome to Wallace sign on Hwy. 117 to be offset by an increase in investment income.

Council Member Carter made a motion to approve the proposed budget amendment. The motion was seconded by Council Member Frank Brinkley and unanimously approved.

Old Business

Hatcher Street Closing Request (Jim Russ property)

Town Manager Larry Bergman reported on a meeting with ALE (Alcohol Law Enforcement) officials. These officials indicated that from a permitting standpoint an ABC permit would probably be approved for the location. Manager Bergman stated that he could not find any documentation as to whether or not it is a public or private alley. Town Attorney Anna Herring stated that the law requires that it be a public alley before it can be closed and recommended the property owner get a full detailed title search as well as a legal description.

The Council took no action on this matter.

PUBLIC HEARINGS

Annexation Petition AX-2022-01 (Gevargis)

Council Member Carlton made a motion to open the public hearing. It was seconded by Council Member Rivas-Diaz and approved by unanimous vote.

Planning Director Rod Fritz said the applicant was requesting annexation of 1.59 acres located at 5412 S. NC 41 Hwy.

There were no comments from the public.

Council Member Brinkley made a motion to close the public hearing which was seconded by Council Member Carlton and unanimously approved.

Annexation Petition AX-2022-02 (Fleer); Rezoning Request RZ#2022-05 Dixon; Rezoning Request RZ#2022-06 Royal Farms

Council Member Brinkley made a motion to open the public hearing, seconded by Council Member Rivas-Diaz and approved unanimously.

Planning Director Fritz stated that this applicant is requesting annexation (AX-2022-02) of approximately 13 acres located on NC Hwy 11, adjacent property is already in the Town limits, there were no comments from the public.

Planning Director Fritz said that the request for rezoning 2022-05 Dixon is 1.2 acres on Hwy 41 across from Dixon's Grill.

Ms. Valerie Sutton who lives on H.C. Powers Road asked what was planned for the location and Planning Director Fritz said Mr.Dixon intends to operate a seasonal famer's market.

Planning Director Fritz the request for rezoning 2022-06 Royal Farms is for approximately 4 acres on Hwy 41 to develop a gas stations, car wash and out parcel fast food restaurant.

Brent Whitfield and Sherry Aramini, residents in an adjacent development, made comments on protecting their neighborhood from noise, lights, drainage and asked about a buffer. Planning Director Fritz said the buffer is the most dense buffer in the ordinance because of the difference in the zoning designations.

There were no additional comments and Council Member Carter made a motion to close the public hearing which was seconded by Council Member Brinkley and unanimously approved.

Action on Public Hearing Items

Council Member Davis made a motion to approve adoption of Ordinance AX-2022-01 (Gevargis) which was seconded by Council Member Carlton and unanimously approved.

Council Member Davis made a motion to approve adoption of Ordinance AX-2022-02 (Fleer). The motion was seconded by Council Member Brinkley and approved by unanimous vote.

Council Member Davis made a motion to amend the Town's Zoning Map and approve the Reasonableness Statement for RZ#2022-05 (Dixon) that was seconded by Council Member Carlton and approved by unanimous vote.

Council Member Davis made a motion to amend the Town's Zoning Map and approve the Reasonableness Statement for RZ#2022-06 (Royal Farms), seconded by Council Member Brinkley and approved unanimously.

Certificate of Sufficiency (Strongrock AX-2022-03) and Adoption of Resolution Fixing Date of Public Hearing

Planning Director Fritz said at their last meeting the Town Council directed the Clerk to investigate the sufficience of AX-2022-03 for the Strongrock development. Having found the petition to be sufficent Fritz asked the Council to adopt a Resolution Fixing the Date for a Public Hearing.

Council Member Davis made a motion to adopt a Resolution Fixing Date of Public Hearing on Question of Annexation (AX2022-03) Pursuant to N.C.G.S. 160A-31 after 6 pm on Thursday, December 8, 2022. The motion was seconded by Council Member Carlton and unanimously approved.

Wallace ABC Board update

Wallace ABC Board Chair Chad Wilson provided an update on sales from July 1, 2022 through October 31 and the status of the debt service on the new facility.

Airport – Four County ROW (Right-of-Way) for AWOS (Automated Weather Observation System)

Airport Manager King asked the Council to approve and execute a ROW Easement allowing electric utilities to be installed as part of the AWOS construction.

Council Member Davis made a motion to approve a the Distribution Right-of-Way Easement that was seconded by Council Member Rivas-Diaz and approved by unanimous vote.

New Business

Boards and Commissions Terms

Manager Bergman stated that the list was appointees serving on Council appointed Board and Commissions with terms expiring at the end of the year. Some members have agreed to be reappointed and there are vacancies on the Planning Board and Historic District Commission. (Appointments will be made at the next meeting.)

Request for Four Way Stop Signs on College Street

Manager Bergman said he has received complaints and request from citizens about speeding traffic and unsafe intersections on S. College Street and at E. Carr Street and E. Cliff Street. The Police Department supports stop signs in that area. Manager Bergman had prepared an ordinance to amend Chapter 73: Traffic Schedules, Schedule III Stop Signs.

Council Member Rivas-Diaz made a motion to adopt the proposed ordinance amendment. The motion was seconded by Council Member Carlton and unanimously approved.

Request for Additional Street Light

Manager Bergman he received a request from a resident on Stevens Street for an additional street light. The Police Department took a look during the night and it was no darker than some other areas in Town. He recommended the Council deny this request.

The Council took no action.

Request for Matching Funds for Historic District Street Signs

Manager Bergman stated that Chamber of Commerce President Ken Floyd has asked the Town to consider allocating matching funds in the amount of \$1,000 to purchase decorative street signs for the historic district. The Town would be responsible for installing and maintaining the signs.

Council Member Carter made a motion to provide the matching funds which was seconded by Council Member Brinkley and approved unanimously.

Customer Service Guidelines

Manager Bergman asked the Council to approve the proposed Utility Customer Service Guidelines for continuity of service for all customers.

Council Member Carlton made a motion to approve the Utility Customer Service Guidelines. The motion was seconded by Council Member Rivas-Diaz and approved by unanimous vote.

Adopt Two (2) Street Closing Resolutions

Manager Bergman explained that in 2003 and 2019 Council adopted Resolutions for closing a portion of Clement St. east of S. Norwood St. but the closing was never recorded at the Register of Deeds Office. The same thing happened in 2016 with a portion of W. Murray St. at N. Orange St. He asked the Council to adopt resolutions for ordering the closing of both.

Council Member Rivas-Diaz made a motion to adopt a Resolution Ordering the Closing of Clement Street east of S. Norwood Street which was seconded by Council Member Brinkley and unanimously approved.

Council Member Carlton made a motion to adop a Resolution Ordering the Closing of West Murray St. at North Orange Street. The motion was seconded by Council Member Carter and approved unanimously.

Finance Reports

Finance Director Taylor commented on the financial reports that it is still early in the year.

Council Reports

Council Member Rivas-Diaz commented on the pot holes on Raleigh Street.

Council Member Brinkley said the new curb and gutter on Harrell Street is already cracking. (The contractor has been notified.)

Council Member Carter commented on code enforcement and having made some progress, need to keep doing what we're doing.

Council Member Davis said to put the bridge railings at Boney Mill on the to do list. He stated that the Police Department handled the shooting incident at the football game very well. Davis reported that the Fire Departmet has responded to 300 calls so far this year.

Council Member Carlton thanked the Fire Department for providing lights at the polling place on Election Day. Ms. Carlton said the program at the new Public Services facility earlier today was very nice.

WHEREAS, it now appears to the satisfaction of the Town Council, Wallace, NC that the closing of said street is not contrary to the public interest, and that no individual owning property, either abutting the street or in the vicinity of the street will as a result of the closing be thereby deprived of a reasonable means of ingress or egress to their property;
